**Minutes of the Annual General Meeting 12<sup>th</sup> May 2016 held in the Iron Room,  
Eglwysfach.**

1. Present: Councillor Swanson (in the chair), Goodman, Griffiths a Thomas. County Councillor ap Gwynn. The clerk was in attendance. Also present: Dr Ian Thomas.
2. Apologies: Councillor Jenkins, Hustings a Thomas.
3. Election of Chair for 2016/17:  
Councillor Toland was nominated as Chair by Councillor Griffiths. The nomination was seconded by Councillor Thomas and elected unopposed. Councillor Swanson was nominated as vice-chair by Councillor Thomas. The nomination was seconded by Councillor Goodman and Councillor Swanson was elected unopposed.
4. Declarations of acceptance: the position of deputy chair was accepted by Councillor Swanson.
5. The minutes of the annual general meeting for 2015/16 were accepted as a correct account of the meeting.
6. A written report for 2015/16 was received from Councillor Toland and presented by Councillor Swanson: The main points were:
  - The playground is undertaken. It was noted that there is finance available from the County Council for projects of this type.

- The community defibrillator is in place.
  - The campaigns for the pavement and access to the station continue.
7. The Clerk gave the financial report for the year. The report was accepted by the Council.
